SWAAG Chair's Column: Breaking Boundaries

There is something about geography that instills in many of its practitioners a rather unique combination of frustration and hope. *Frustration*: geographers are sometimes viewed as glorified game show fact providers. Alex Trebek, please don't call me – I might be able to tell you the name of the highest point in Kansas (Mount Sunflower!), but I really don't want to. It is at times daunting to know that some substantial portion of the public at large sees geography as focused on fact collection. However, balanced against this challenge is an equally strong sense of *hope*: geography is relevant to many of the most crucial issues faced by people across the planet. We know this, because we have seen the contribution our work continues to make in so many human and physical settings. Such knowledge and conviction energize us, and we continue with our efforts.

Yet given this background, a crucial question emerges: how can we expand the community that truly understands and supports our work? One key element of the answer to this question would inevitably appear to include more and better collaboration and outreach efforts that lead to involving more people that have some substantial contact with real, live geographers. Expanding our working groups, gathering improved ideas from a broadened community, and consciously reaching out to more potential users of our expertise are all positive ways of opening up the practice of geography to our fellow citizens.

To this end, I extend a hearty invitation for us all to meet at SWAAG's 2014 annual meeting in Albuquerque, New Mexico (October 23-25). Our "Breaking Boundaries" meeting theme is a timely one, for all of the reasons advanced above, and because our meeting

Message from the Regional Councilor

Greetings to all SWAAG members! As your Regional Councilor and current Chair of the Regional Councilors, I offer the following as a brief update on the activities of the Council of the Association of American Geographers (AAG). Regional and National Councilors meet twice a year with past/current/in-coming AAG Presidents, the Executive Director (Doug Richardson), and many of the staff members from the executive office. Although the executive office handles most day-to-day and conference-planning responsibilities, the Council is charged with oversight and promulgating new rules, awards, and initiatives.

There has been a great deal of solidarity among regional councilors of late to press the AAG for more direct support to regional divisions. In response, the Executive Director and the Council provided travel funds to regional chairs and hosted a workshop in Tampa last spring for division officers aimed at developing a best practices manual for current and future division officers. This and other information will now be shared among regional divisions on a common website hosted at AAG. The AAG also offered to assist, on an elective basis, in accounting, conference-hosting, and membership management. This allows SWAAG and its regional counterparts to have access to a suite of business tools that should streamline the management of membership records and fall conferences. Officers from regional divisions were also invited to participate in the current round of long-range planning meetings being held by the association. In short, regional divisions of the AAG remain relevant, active, and now have even more support to build, recruit, and meet regularly.

There are a number of topics of national concern that continue to be discussed in Council. Although there are mixed opinions on the trend, the AAG remains attentive to the "re-branding" of departments and programs around the country. Data are being gathered on these changes nationally and will be shared with members as they become available. The Council also remains interested in the evolving role of online education, specifically the influence of Massive Open Online

Courses (MOOCs) and the rising popularity of online masters programs (especially in the geographic information sciences). Doug Richardson has reported frequently on the association's efforts to help defend social science funding at NSF and beyond. More details on those efforts can be found on the main website (www.aag.org). These are just a few of the topics being considered in Council and there are many more coming. Please go online to discover more on new initiatives, new awards/scholarships, and new events to be held in Chicago next spring.

Regional Councilors serve three-year terms and are not eligible for re-election. My term as SWAAG Regional Councilor will be up spring 2015 at the Chicago, IL meeting and SWAAG leadership will call for nominations for the next councilor at this fall's meeting in Albuquerque, NM. If your calendar permits the commitment, I highly recommend the assignment. It has been an honor to represent my colleagues in SWAAG, it has been a pleasure to get know my fellow Council members, and I have been consistently impressed by the kindness and dedication of the AAG staff. Our regional divisions represent the foundation of a growing national/international association with long-standing roots in our discipline and increasing influence over national debates relevant to geographic practice, research and education. It is a great time to serve...and quite a bit of fun to boot!

Please make plans now to attend this year's SWAAG regional meeting, which will be held in Albuquerque, New Mexico from October 23-25. The meeting is shaping up very nicely, and we look forward to meeting jointly for the first time with our colleagues from the Great Plains / Rocky Mountain region. We at the University of New Mexico are handling all local arrangements, with our partner and co-organizer Kansas State University handling registration and program logistics. I hope everyone has now seen that registration is open, with abstracts due by September 12. Please note that on-site registration will be available as usual, but registration fees will increase substantially after October 15. For information about travel, lodging,

Events and Schedule Overview

Hotel Andaluz is the conference hotel, with some events also held at the Albuquerque Convention Center, just one block away. Andaluz will host everything on Thursday 10/23, including registration, afternoon paper sessions, and a reception that evening. (We are still planning a student mixer for Thursday night at a downtown brewery; follow us on Twitter for details.) On Friday 10/24, we will move to the convention center for paper sessions, with keynote speaker Scott Collins joining us at lunch, before heading back to Andaluz for GeoBowl and the two regions' business meetings in the late afternoon. We are especially excited to announce that Friday evening's awards banquet, featuring a keynote talk by AAG President Mona Domosh, will be held at the historic Albuquerque Railyards space, a renovated former rail warehouse in a revitalized part of downtown. We have an outstanding slate of field trips for Saturday 8/25, all of which will depart from Hotel Andaluz. I am told there is currently room available in all four field trips, but they will surely fill quickly, so please register soon!

Lodging

There are still rooms available at the gorgeous and newly renovated Hotel Andaluz at our conference rate of \$118 for 1-2 guests. (If you register online, use the group code "1410UNMGEO" but if you call, simply refer to "UNM Geography.") The cutoff date for this rate is October 10, but I'm sure the block will sell out before that. If you are looking to avoid downtown hotel rates, there are many cheaper motel options for those willing to brave Route 66, also known as Central Avenue. The conference website lists addresses and rates for these motel options, along with a few other hotels in town.

Transportation

Please note that your conference registration will include a city bus pass, good for all routes. All conference venues are easily accessible by bus, and we will provide a van shuttle for anyone who does not want to walk to the Railyards. As you can see on the map, Hotel Andaluz is only 2 blocks from the main rail station and bus depot, and Central Avenue (historic Route 66) is

the main bus corridor through the city, with multiple overlapping bus lines available for those who choose motel lodging. In addition, cab fare to and from the airport is very reasonable from downtown. Bottom line: unless you are planning to do a field excursion outside the city during your stay, I would encourage you to use public transit instead of renting a car that will spend two days parked at Hotel Andaluz.

Again, we look forward to hosting you all at SWAAG. A number of special sessions have been proposed and are listed on the conference website. Please feel free to contact me or my co-organizer Shawn Hutchinson with any questions about sessions, papers, registration, etc.

The meeting venue provided opportunities to combine sharing research accomplishments, catching up with friends and getting to know geographers and geospatial scientists from across the South. The conference started with a series of paper sessions followed by a social around the pool of the Hotel Fredonia. Music was provided by SFA faculty members Jenna Paul- and Juan Carlos Urena. Their world music selections provided a festive part for a pleasant evening of conversations and dining.

On Friday concurrent sessions offered attendees a variety of paper and poster sessions to experience a

diversity of ongoing research projects being carried out around the globe at various scales, extending from Antarctica to our own back yards utilizing interpersonal to geospatial methodologies and techniques, all with the intent to better understand our planet and its complex interactions.

The lunch plenary speaker was Phil Cross, a member of the Caddo Indian Nation and the Caddo Culture Club at Binger, OK. Over twenty years, Phil has been involved with enriching audiences' understanding of the Caddo heritage. He specializes in Caddo archery and building traditional Caddo grass-thatched houses. In his presentation, Phil retraced the actions that lead to the relocation of the Caddo peoples over a 500 year period to their present reservation in Oklahoma. A series of maps provided a visual context that Phil used to expand upon the social and cultural implications of the historical events. Dr. Julie Winkler delivered the plenary address Friday evening of the conference. Dr. Winkler explored two themes in her presentation: The Climate of Geography and an overview of her important contributions to climate modeling research. Dr. Winkler pointed that Geography was in a positive position at the current time

with a growing appreciation of geographers' diverse interests and collaborations. The central focus of her presentation explored her and colleagues research on understanding changing human landscapes under a changing climate through more sophisticated climate assessment ensemble models. Recent findings suggest key areas for additional research are choice of assessment strategy, constraints of climate spatial linkages and interactions, interpretations of climate projection and uncertainty ensemble models, and

consideration of landscape-climate influences.

The journal staff is completing the journal's migration to open-access on-line publishing by posting digital reproduction of all past volumes of the journal. The editors suggest that authors of previously published journal articles should review the metadata attached to their articles on-line and forward any changes and additions (including keywords and subject descriptions) to John Tiefenbacher (tief@txstate.edu). These data will be updated as appropriate and will assist access to readership searching on web-based search engines. Each article will soon appear in search results on scholarly search engines based upon their titles,

abstracts, and keywords and will (eventually) have unique DOI identifiers. Readers, and all users in fact, must register (though it is free) in order to access the articles from all issues. Future issues of The Southwestern Geographer will be available only on-line. Papers will become available upon acceptance and after each has been copy-edited and laid out in journal format. Each article will soon appear in search results on scholarly search engines based upon their titles, abstracts, and keywords and will (eventually) have unique DOI identifiers.
